Summary

Supplemental:

On October 6, 2018 at approximately 2045 hours, I had contact with my neighbors Tyler Brown and Bailey Dixson at 561 East 15th Place. It was a verbal argument between an unknown female and Dixson. All parties were separated when I made contact. Brown and Dixson stated a physical altercation occurred earlier in the evening and no one was hurt. Brown was only getting stuff to stay the night at a family's house and the unknown female is Brown's sister. Due to Brown and Dixson being domestic partners and Dixson's child was at the residence when the altercation occurred, I called the on-duty Officer, Officer Gray and informed him of the incident as per a mandatory reporter. Parties separated and were told that an Officer or Child Protective Services would be in contact with them.

On October 7, 2018 I was outside and had contact with Brown and Dixson. Dixson still had slight scratches on her neck and Brown did not have any visible marks from the altercation the night before.

On October 8, 2018 attempted to contact Officer Gray to update on the incident, no call back. I informed Chief Sander's of the incident and provided statements to him.

On October 12, 2018 Chief Sanders contacted me and requested I did a supplemental report for the incident.

On October 17, 2018 spoke with Officer Gray about doing the supplemental since returning from vacation. After a discussion Officer Gray stated he would take a case number and type up a report. Chief Sanders and I discussed the incident and I would be attaching my supplemental to the report once finished.

On October 25, 2018, I contacted Officer Gray regarding a follow up since I was still waiting to submit my supplemental and have not received any updates about the case. Officer Gray stated he was typing up the report and had finished his interviews.

On October 31, 2018 at approximately 1515 hours, Chief Sanders emailed me stating he sent me Officer Gray's report. Chief Sanders instructed me to proof read my supplemental and attach it with the report. Once finished to send it to him.

No further action from this Officer.

Action Taken

Supplemental:

On October 6, 2018 at approximately 2045 hours, I was off duty, not in uniform, not displaying a badge, not operating a patrol vehicle, not working for the Coquille Police Department, County of Coos, State of Oregon. I contacted my neighbors Tyler Brown, Bailey Dixson, and an unknown female who were verbally arguing outside the residence at 561 East 15th Place.

Earlier in the evening while outside Barbequing I heard Brown and Dixson verbally arguing and Brown getting in his vehicle. Brown backed out and drove away from his residence. Awhile later, I heard Dixson outside on her phone talking to someone.

Later that night, I had the windows open in my residence and could hear an unknown female and Brown talking loudly. I stood in our bedroom and listen to what was happening next door. I heard the unknown female start raising her voice to the point of almost yelling saying "I'm going to call 911!". I looked out my window and could only see the unknown female and Brown standing at the garage entrance. It appeared Dixson was talking back from inside the residence through an open door to them. Brown and Dixson continued verbally arguing and the unknown female persisted to tell Dixson she was calling the Police and Department of Human Services to get Dixson's daughter taken away.

After a brief minute, they de-escaladed and were no longer arguing. I made the decision to walk over and make sure everyone was okay. Brown and Dixson have lived next door to my residence for approximately four months and have weekly contact with me.

As I approached their residence Brown was standing with the unknown female. I told everyone I was coming over as their neighbor and not as a Police Officer since I was off duty. I asked Brown if everything was okay, Brown stated it was and apologized for being loud and keeping me awake. I asked what was going on. Brown stated his sister was with him to help get some stuff and he was staying at his father's residence for the night. Brown stated him, and Dixson had an altercation earlier in the evening. The unknown female stated Dixson's child is at the residence and Dixson is intoxicated.

While talking to Brown, Brown stated that him, and Dixson had an altercation and it was physical. Brown said that Dixson punched him in the mouth causing the inside of his lip to bleed from hitting a tooth. I did not observe any marks or bruises.

Brown continued to tell me this occurred earlier in the evening. Brown stated after the altercation,

Dixson and Brown realized they both made poor choices and Brown choose to leave the residence. While Brown was talking to me, Dixson came to the back door and I told Dixson I was over there.

Dixson went back inside, and Brown continued to tell me that Dixson had taped screws on the asphalt and deflated his front tires on his vehicle. Brown told me Dixson also kicked his car and put a dent in the side of the vehicle. I observed the flat tires and the dent.

I told Brown that none of what he has told me was okay and that as a mandatory reporter I would have to call this in. Brown went inside to finish grabbing items he needed for the night.

Dixson exited the residence and told me everything was okay, as her daughter came outside and started drawing on the ground with chalk.

Dixson told me the argument with Brown escalate until a point when Brown pushed her to the ground with his hand on her lower neck along the left side where her shoulder meets. I observed marks on Dixson's lower neck, it appeared like red marks. The marks were bright red almost like scratches.

While outside Dixson stated her daughter was in the living room doing something. Dixson told me the arguing and physical altercation occurred across the house in one of the bedrooms. I asked Dixson if she was okay, Dixson said yes and was not in any pain.

Dixson stated her friend told her she should put the screws down in the drive way to get back at him. Dixson told me it was stupid and everything that happened this evening was very stupid and apologized that it caused me to come over.

After Dixson finished talking, I told her it puts me in an awkward position. I told Dixson I was here as a concerned neighbor not as a Police Officer. I explained to Dixson that I had to make a phone call regarding what I witnessed. I explained to Dixson that as a Mandatory Reporter, more likely than not, Child Welfare will be informed of the incident and people will be contacting Brown and herself. Dixson told me she understood.

After talking to Dixson, I walked back over by the garage and Brown was putting stuff in a vehicle about to leave. Brown's sister the unknown female told me she thought I was a nice person and was glad that I came over to check on my neighbors. The unknown female also stated her friend works for Child Services and she would be calling her about the incident that occurred. I told the unknown female and Brown that after I make a few calls, I as well would contact Child Services if I needed to.

Based on what I observed, I walked back to my residence and immediately called the on-duty officer for Coquille which was Officer Justin Gray. At approximately 2058 hours, Officer Gray answered my call. I asked if he was busy, Officer Gray stated he was in route to a medical call and asked what was up. I did not hear any sirens and it did not sound like Officer Gray was running code. I told Officer Gray that I had just been next door with my neighbors who reported a physical domestic altercation that occurred earlier in the evening. I told Officer Gray that the parties had been separated for a while and things were code 4 now.

Officer Gray said okay, and I continued to explain what I witnessed. I explained what caused me to go over and check on them after hearing the yelling while I was inside my residence. I explained that both parties admitted to being physical during the altercation and that Brown had a possible cut on his lip, Dixson had the marks like scratches on her neck. I told Officer Gray a child was in

the residence during the incident but from what I could tell, the child was not aware of the physical altercation. I told Officer Gray I wanted to make sure I was doing the right things as a mandatory reporter. Officer Gray acknowledged what I told him.

I continued explaining that neither party wanted to call the Police. I told Officer Gray I was not sure if anyone will call 911 but if they do or if he needs more information from me, to call me and I can explain everything I observed. I told Officer Gray I could call Department of Human Services on Monday if I needed to provide a statement. Officer Gray acknowledge what I told him and stated he would contact me if he needed more information from me.

I left it to the on-duty officer with the assumption that Officer Gray would respond after the medical call he was out on. (Phone call was approximately 1 minute 55 secs, see photo).

On October 7, 2018 while outside cleaning my personal vehicle, I had contact with Dixson and Brown. They both briefly said things were better. I did not observe and injuries on Brown and the mark on Dixson was almost gone completely.

On October 8, 2018 at approximately 1204 hours, Officer Gray text me asking for the address of my neighbors that I had called him about on Saturday night. I attempted to call him but was forwarded to a voicemail and got a text stating he was busy. I text him the address and names of the parties involved. I called Chief Sander's at approximately 1223 hours and inquired about the situation since no one had contacted my neighbors or updated me about the situation. (See photos of phone calls and text).

Chief Sanders told me that Officer Gray had forgot to follow up on the call and the dayshift Officer did not have contact with my neighbors yet. I asked Chief Sanders what I needed to do, Chief Sanders told me that Officer Gray would contact me and do an interview. I asked if I needed to call Department of Human Services, Chief Sanders stated Officer Gray would handle it. (Phone call was approximately 15 minutes and 5 seconds).

On October 12, 2018 Chief Sanders text, me stating someone complained to Department of Human Services that the department did not do anything about the domestic incident my neighbors had. In the text Chief Sanders mentioned that Officer Gray had done a follow up with both parties, but they denied everything, and Brown had not moved out yet. I asked Chief Sanders to call me.

At 1343 hours, Chief Sanders called me and asked if Officer Gray had contacted me, I stated no one had. I told Chief Sanders that I have observed Officer Gray and Officer Sanne on my road and when I asked if anyone has contacted my neighbors, they said not yet. During the phone call I asked if there was anything else I need to do because this was starting to become and issue that needs a supervisor involvement. Chief Sanders told me to type up a supplemental report when I come back from vacation and attach it to the case number that Officer Gray is generating on his shift.

During the phone call I mentioned that I made the mistake of not calling dispatch and calling the on-duty Officer directly. Chief Sanders advised me that in future incidents to just call dispatch or 911 and then a call will be generated so that the Officer does not forget to respond or forget to conduct a follow up. (See photo of call, approximately 10 minutes and 35 seconds).

On October 17, 2018 at 0600 hours when I came on duty, I told Officer Gray I was going to review the Department of Human Service report that was in his box and type up a narrative like Chief Sanders instructed me to do. Officer Gray told me he would do a supplemental for my report. I told

Officer Gray, Chief Sanders stated that he was responsible for the investigation and report. I was supposed to type up a supplemental.

Officer Gray asked me what happened again during my contact with my neighbors. I told Officer Gray "The same stuff I said to you on the phone" and continued restating the same information.

Officer Gray asked me to call dispatch and have them turn his L# into a Q# under his number and to attach my supplemental. Officer Gray stated he would read my narrative, then type up a report.

When Chief Sanders came on duty, I asked if I should pull the case number for Officer Gray. Chief Sanders told me that Officer Gray was supposed to already have done that and was supposed to call me the night before to do a phone interview. I told Chief Sanders Officer Gray has not spoken to me other then the one time he texted me and at the beginning of today's shift. Chief Sanders told me to finish my supplemental report and to wait until Officer Gray completes a report to attach it for Chief Sanders to review.

On October 25, 2018, I spoke to Officer Gray regarding a follow up since I was still waiting to submit my supplemental and have not received any updates about the case. Officer Gray stated he was typing up the report and had finished his interviews. Officer Gray mentioned neither party discussed the altercation being physical and would be referring the report. I explained that my supplemental was done and would get it attached to the report when I returned from training. (See photo of phone call, approximately 2 minutes and 58 seconds).

On October 31, 2018 at approximately 1515 hours, Chief Sanders emailed me stating he sent me Officer Gray's report. Chief Sanders instructed me to proof read my supplemental and attach it with the report. Once finished to send it to him. (See attached photo of email).

No further action from this Officer at this time.

Action Taken

On 10-06-2018 at approximately 2058 hours, I was on duty, in uniform, displaying a badge, operating a marked patrol vehicle, working for the Coquille Police Department, County of Coos. State of Oregon. I received a phone call from Officer Clayton Makinson who was not on duty. Officer Makinson advised me that his neighbors had been in an argument in the driveway and that the parties were separated, and he had broken up the argument. I was currently on my way to a medical call and Makinson advised me that the incident was handled and since there was a child present, he would be pulling a case number and be referring it to DHS. Officer Makinson advised me that he was unsure if it was physical or not but the male and female were separated for the evening and the male left. Officer Makinson advised me that he had handled the situation and just wanted me to know incase something came up later in the evening. I later looked at the length of the phone conversation and it was a elapsed time of one minute.

On 10-08-2018 I contacted Chief Sanders and advised him of the situation. I felt that I should at least let him know what had been conveyed to me as Officer Makinson was not the duty Officer, nor was he on duty that evening. Chief was told of the circumstances and he advised me that he would talk to Officer Makinson. Chief Sanders also informed me to do a follow up with the residence on my next scheduled duty day to make sure a crime had not occurred.

On the same day I sent Officer Makinson a text message requesting the exact address and the

individuals that were involved. Officer Makinson responded with a message that advised me that the address was 561 East 15th Place, Coquille Oregon. The text message also read "Not Sure Baileys last name. Trevor has arrested her last year. The dudes' plate is 367GKL. Basically, from what they were telling me when I made sure nobody was killing each other they both were at faults they know they both committed stuff they shouldn't have done, and the little girl wasn't present during the physical altercation but was still in the house."

On 10-10-2018 I requested that Officer Sanne try and contact Bailey Dixon and Tyler Brown. I was advised that he was only able to contact Brown who was at work and he was informed that nothing physical occurred on 10-06-2018.

On 10-10-2018 at approximately 1829 hours, I conducted interviews with Bailey Dixon and Tyler Brown at the residence that was earlier mentioned. I asked both parties what had taken place and they advised me that nothing occurred during the incident. Both parties advised me that nothing physical took place and that there was a verbal argument only. Dixon advised me that the argument was over the fact that Brown and Dixon had broken up after an almost one-year long relationship. Dixon informed me that Brown then started dating one of Dixon's friends and Dixon confronted Brown about it. Dixon did inform me that there was an argument and her 3 year old daughter was in the other room during the argument.

On 10-12-2018 I was off duty and I was notified that there was a Department of Human Services report that had came to the Office. The summary of the report advises that Dixon had struck Brown and gave him a bloody lip. It also states that Brown choked Dixon and left marks on her neck. According to the report the juvenile was present during the incident.

On the same day I spoke to Chief Sanders again and based off the report he wanted me to do some more follow up on the case based off the DHS report that was filed.

On 10-16-2018 at approximately 1830 hours, I spoke with the DHS worker who took the report and got the contact information for the sister of Tyler Brown. I was advised that to date there was no referral from any officers from the Coquille Police Department and that concerned them based on the circumstances.

On 10-16-2018 at approximately 1830 hours, I conducted a phone interview with Hailie Brown. I asked Hailie what had taken place on the night of 10-06-2018 and how she got the information. Hailie advised me that she did not witness any of the altercation. Hailie did advise me when she picked Brown that he had some bruising around his eye, bloody swollen lip and he had some scratches on his chest and possibly shoulders.

Hailie advised me that she asked Brown if he called the cops and Brown advised Hailie that it had became physical between both Brown and Dixon and he didn't want the cops involved. Hailie advised me that why she was there Dixon came outside and Hailie screamed at Dixon that she would call the cops loud and that's when the Officer Makinson came over.

Hailie advised me that Brown told Halie that Dixon was intoxicated and began screaming at Brown about Brown being in a relationship with Dixon's friend. Brown tried to leave, and Dixon ripped Brown's shirt. Brown then left, and Dixon went outside and began throwing screwdrivers and other items at Brown's vehicle that was in the driveway that resulted in Brown getting a flat tire which is why he needed a ride.

Haile advised me that when Officer Makinson came over to break up the argument that Hailie *5リコチ1リチコイハ* observed some marks on Dixon's neck.

Hailie informed me that in the past when she resided with Brown and Dixon she had witnessed Dixon become very uncontrollable and aggressive when Dixon would drink alcohol.

Hailie advised me that Brown later disclosed to Hailie that during the altercation Dixon was hitting Brown and that's when he attempted to push Dixon away. During the pushing by Brown advises Hailie that he pushed Dixon by the neck and Dixon hit her head on the wall.

On 10-16-2018 at approximately 2049 hours, I conducted a follow up interview with Brown. During the interview Officer Wallace was present. The interview was recorded, and Brown was aware of the recording.

During the interview I advised Brown about the DHS referral that had been reported. I informed him that Hailie had also informed me of the things that Brown disclosed to Hailie that had taken place. Brown declined that anything had happened. Brown advised that there was nothing physical that night that took place. Brown did advise Officer Wallace that there had been physical contact in the past where Dixon had struck Brown. Brown said that it wasn't anything that he couldn't handle. Brown also advised me that he never put his hands-on Dixon.

I asked Brown if he had talked to the Officer Makinson on the day of the incident. Brown advised me that Officer Makinson had came over and asked everything that was going on. Brown said that Officer Makinson came over when Hailie and Dixon were screaming at each other. I asked Brown if Officer Makinson had interviewed them at all. Brown advised me not really Officer Makinson just said he would like to get it all figured out without getting the cops involved, and that it would probably be best if it got worked out between Brown and Dixon without the cops getting involved. Officer Makinson calmed Dixon down. Officer Makinson advised Brown that he was there as his neighbor and not as an Officer.

I concluded the interview with Brown.

On 10-17-2018 at approximately 0600 hours, I was going off duty and Officer Makinson was relieving me. I again asked Officer Makinson what had taken place that night and what he witnessed. Officer Makinson informed me that he was advised that there was a physical altercation between Brown and Dixon and Dixon had struck Brown and Brown had choked Dixon. Officer Makinson said he witnessed Brown to have a bloody lip and Dixon was very upset. Officer Makinson said he came over because Dixon and Hailie were screaming at each other. Officer Makinson advised me that he separated the parties and that was when he called me shortly thereafter.

I attempted to speak with Dixon again on the telephone and she said she was busy and didn't want to talk to me.

A copy of the DHS report and all interviews will be attached to this report. Based on the lack of physical evidence and testimonies there was no arrests made.
